Site Plan Review for 3034 Jackson Highway Duplexes at Lewis County Parcel 017840015003 zoned R-1 – Single-Family, Low Density on approximately 1.24 acres.

Planning- Define parking stalls and call out count on the Site Plan.

Water- Capital Facility charges will apply.

Within the UGA- water meters shall be placed in the right of way and within two feet of the property line nearest the customer's premises. Water must be hooked up to the water main located on Jackson Highway. Each premises shall have a separate water meter. Per CMC 13.04.060

Storm Water- 2019 Storm Water manual applies to all

Will need an easement for all utilities.

All work in the Lewis County Right of Way will require a ROW permit to be applied for through Lewis County.

Streets- Full frontage improvements required on Jackson Hwy- Curb, Gutter, Sidewalks, and Streetlights. Will need a shared access agreement for the driveway with 3038 Jackson Hwy.

Sewer- Capital Facility Charges will apply, verify the sewer connection in the manhole is not too close to the existing connection if so, may have to replace the line with a larger pipe.

Fire- 6" address numbers required on the face of the buildings.

Justin Phelps- Motion to Approve with conditions, Michael Thomas seconds, all vote- Site plan is approved with conditions.

9:30 AM SE-24-010; Special Event Permit at 900 Airport Road Airport sponsored Swap Meet/Garage Sale Fundraiser.

Streets- Signs will need to be removed after the event, 72 hour advance notice required to be posted if event plans on no parking signs.

Public Works- Right of Way Occupancy permit required for all signs in the right of way.

Mike Thomas- Motion to approve the event, Fritz Beierle seconds, all vote- Special Event Approved.

10:00 AM SE-24-011; Special Event Permit for WF West Class of 2024 Senior Cruise Student cruise from WF West High School to Bethel Church on June 2nd, 2024

Police- Can provide one officer unless there is an emergency/priority call. The one officer can lead the line of vehicles through the city limits, then break off on 20th street to block traffic until all cars are clear on 20th. All vehicles must obey traffic laws and stop signs.

Streets- Day and time should have minimal traffic on the roads.

Public Works- May need right of way permits from Lewis County for the portion of the event that is not in the City limits. Applicants will need to contact Lewis County.

Streets- Type 3 Barricades on site and available for the event staff to set up/take down for the event. Must post notice of street/parking closure 72 hours in advance.

Police- Suggest restricting parking if there are road closures

Public Works- Notify Lemay/Transit services on road closures, Right of Way Permit required.

Planning- Chehalis Municipal Code Parade regulations- 5.04.130
